

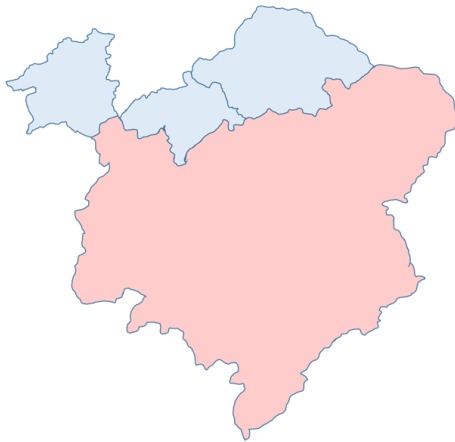

## Community Sergeant Update



The Local Police Plan 2020-23 for the Lothians and Scottish Borders identifies five strands for police to focus on during this period. These strands are; *Protecting the most vulnerable people, reducing violence and anti-social behaviour, reducing acquisitive crime, improving road safety and tackling serious & organised crime*. While each of these areas generally have specialist units that are individually dedicated to each strand, such as Roads Policing or CID, Community Policing is at the forefront of prevention work in all of these areas. I previously mentioned our work with the Scottish Partnership Against Rural Crime (*reducing acquisitive crime strand*) and last month Op Torsion and the work of the School Link Officers (*reducing violence and anti-social behaviour strand*). We are also frequently involved in campaigns such as the one shown above (with Borders Women's Aid) during the recent White Ribbon Campaign (*protecting the most vulnerable people strand*).

The Lothian and Scottish Borders Local Police Plan is derived from Police Scotland's Annual Police Plan 2022/23, which identified Domestic Abuse as a national priority. I see the preventions work carried out by Community Beat Officers in their local communities as integral to this, particularly in their work with partners, educating communities and raising awareness. The White Ribbon Campaign comprised of White Ribbon Day on 25<sup>th</sup> November and a subsequent 16 Days of Activism Against Gender-Based Violence. It is the leading charity engaging men and boys to end violence against women and girls. I look forward to the Community Team being part of a wide variety of campaigns in 2024, including Road Safety, Mental Health Awareness, Rural Alerts, Hate Crime Campaigns, Cybercrime and numerous others.

### Protecting most vulnerable

*In November 2023 Police in the Scottish Borders attended and were involved with around 196 mental health related calls, around 25 missing person enquiries and approximately 78 domestic related incidents.*

*Tweeddale East and West had 13 mental health related calls and 2 missing person enquiries. Due to GDPR and protection of victims/subjects involved, we are unable to share any more specific information in relation to these type of call within this report.*

*Police Scotland work in collaboration with key partners to assist the most vulnerable within the communities and to provide support.*



## **Reducing Violence and Anti-Social Behaviour**

### **Assaults**

04/11/23 – report received of a male being assaulted while removing persons from licensed premises in Northgate, Peebles.

11/11/23 – report received of a male being assaulted in High Street, Peebles.

### **Anti-Social Behaviour**

02/11/23 – a male has been reported to the Procurator Fiscal for shouting abuse outside Broughton Primary School.

11/11/23 – report received of youths underage drinking in Edinburgh Road, Peebles due to the call being anonymous and no further calls no officers were dispatched.

13/11/23 – report received regarding youths causing a nuisance at a property in Dovecot Road, Peebles.

14/11/23 – report received of a door being kicked at Provost Walker Court, Peebles.

18/11/23 – Complaint received of youths playing loud music near to Victoria Park, Peebles. Due to the time of day (early afternoon) no officers were dispatched.

18/11/23 – report of youths causing a disturbance on Tweed Green, Peebles. Officers attended and two intoxicated youths were taken home.

18/11/23 – Officers issued an Anti-Social Behaviour Fixed Penalty to a male who was urinating in a doorway of a property in High Street, Peebles.

## OFFICIAL

24/11/23 – Report of youths kicking a door of a property in Waverley Road, Innerleithen.

25/11/23 – anonymous report of youths being abusive to people they were passing in Victoria Park, Peebles. Due to the call being anonymous and no criminality being made to the caller and no further calls received no officers were dispatched.

25/11/23 – report of youths having congregated outside Eastgate Theatre, Peebles. They had moved on prior to officers attending.

### **Vandalism**

12/11/23 – report of damage being caused to the male and female toilets at East Station Car Park, Peebles.

20/11/23 – report of graffiti on some of the play equipment at the Play Park in Victoria Park, Peebles.

21/11/23 – report of door to Youth Club in School Brae, Peebles being damaged.

22/11/23 – report of a door being damaged at a property in Dovecot Road, Peebles.

22/11/23 – reports received of a window, doors and a bin being damaged at properties in Kingsland Square, Peebles.



## **Reducing Acquisitive Crime**

### **Theft by Housebreaking**

Between 01/11/23 and 08/11/23 a property in Carlops Road, West Linton was broken into and a quantity of jewellery stolen.

A property in Craigerne Lane, Peebles was broken into between 2<sup>nd</sup> and 9<sup>th</sup> November.

Between 11<sup>th</sup> and 12<sup>th</sup> November a property in Edderston Road, Peebles was broken into and items stolen.

Between 30<sup>th</sup> October and 17<sup>th</sup> November a property in Glen Road, Peebles was broken into and items stolen.

Between 13<sup>th</sup> and 27<sup>th</sup> November a shed at a property in Lyne Park, West Linton was broken into and ladders stolen.

## Improving Road Safety

### Killed or Seriously Injured

There were no fatal or serious injury accidents occurred in Tweeddale during November.

### Road Traffic Offences

11/11/23 – A cyclist has been reported for dangerous cycling after a collision with a motor cycle on the B709 near Innerleithen Golf Club.

16/11/23 – A driver was issued with a Conditional Offer for careless driving after a collision with a pedal cyclist on the A72 at Neidpath Road Car Park, Peebles.

18/11/23 – A driver has been reported to the Procurator Fiscal for various road traffic offences after being stopped on the A72 near Clovenfords.

20/11/23 – A vehicle was seized for no insurance and the driver reported to the Procurator Fiscal after being stopped in Kingsmeadows Road, Peebles.

25/11/23 – A driver was issued a fine and penalty points after being stopped on A72 near Horsbrugh Ford for having no insurance.

On 14<sup>th</sup> November Road Policing officers along with partner agencies carried out a check at the Nutwood Layby on the A72. A total of 54 vehicles were checked – these included

- 6 Lorries, 23 Vans, 16 Cars, 9 Pickups/Trailers

There were

3 – Vehicle Rectifications issued

2 – Immediate Prohibitions

1 – Delayed Prohibition

5 – Construction and Use Warnings issued

## Tackling Serious and Organised Crime



The Scottish Borders CID Proactive Unit executed 7 Drug Warrants across the command area during November, four were positive and 8 persons were charged with drug related offences. This included another large / industrial scale Cannabis cultivation which had a potential street value of £1,250,000 which was well publicised in local and national media.

They have also been liaising with a number of forces in England in relation to further criminality involving county lines nominals and rural acquisitive crime, particularly in the Eastern are of the Scottish Borders. Inquiries here are ongoing.

Five warrants were also executed in conjunction with other departments in relation to stolen property searches across the Scottish Borders.

They would also like to highlight that the local communities across the Borders may have information which they deem insignificant in relation to people being seen at disused large premises over a period of time. Any suspicious activity will be followed up by this team but it is important that the public know they can report such matters in person at any Police Station, by use of 101 or anonymously via the Crime Stoppers charity.

A number of bespoke business cards explaining the benefits of and reassuring any caller to Crime Stoppers have been produced and can be circulated amongst the Wards should this be deemed useful.

## Campaigns

### Keep Safe Initiative

Primarily aimed at disabled members of the community helping to tackle disability hate crime, Keep Safe is a national network of over 800 safe places (including shops, libraries, pubs etc.) for anyone who may feel lost, scared or vulnerable when out in the community. All Scottish Borders Co-ops have signed up to the scheme with staff training, business packs and store signage being provided.

### Divisional Domestic Abuse campaign

Ongoing engagement with main local employers to share campaign messages, information in relation to local support services and charities and prevention messages targeting perpetrators directly.

### Rural

Scottish Borders Partnership against Rural Crime (SBPARC) the partnership continues to meet regularly to address local priority rural crime throughout the year.

### No Cold Calling Zones



## OFFICIAL

- A new Zone has been set up in Eddleston covering 120 Houses – Road signs and house-packs have been provided.
- Implementation work is ongoing with Bowden and Newtown St Boswells community councils for zones in these areas.

### CAT Update:

#### **SBCAT MMW REPORT:**

During the past month SBCAT officers carried out High Visibility foot patrols and worked alongside other community agencies at various locations throughout the Scottish Borders during the three days around bonfire night

**ROAD SAFETY** – SBCAT have continued carrying out road checks in numerous locations in the Scottish Borders and have issued 8 traffic tickets for various offences throughout the month.

Following concerns regarding antisocial driving at Tesco, Galashiels, regular checks were carried out during the month in line with direct CAT taskings, 1 driver was charged for no insurance and his vehicle was seized.

**PARKING TICKETS** – Officers have been carrying out high visibility patrols in Peebles, Kelso, Eyemouth, Duns, Selkirk, Galashiels, and Hawick, and addressing parking concerns there. Advice has been given to drivers and 119 tickets have been issued.

Passing attention was given to Traquare Road, Innerleithen (no issues) The War Memorial in Coldstream (no issues) Galashiels Town Centre and Bridge Street in Kelso were also regularly checked by officers, which was also carried out as a result of requests made at the previous meeting.

**RURAL ACQUISITIVE CRIME** – We continue to carry out static road checks in rural areas at all times of day to deter and detect rural acquisitive crime. 57 static checks were carried out throughout the Scottish Borders in November.

## OFFICIAL

Regular patrols have been carried out at Monynut with nothing to report.

During the month, SBCAT officers took part in Operation Checkpoint alongside neighbouring forces. As a result of this, a number of traffic offences were detected and tickets issued.

**ANTISOCIAL BEHAVIOUR** – High visibility patrols have continued in targeted areas of the Scottish Borders to address concerns highlighted at these locations.

4 youth warning letters were issued during the month of November in relation to youths entering and causing bother at the Cinema in Galashiels.

On 6/11/23 a male was found to be D and I in Hawick and was issued with a police warning ticket.

**PROTECTING VULNERABLE PEOPLE** – Part of the SBCAT role is to trace persons wanted on warrant/missing person/and bail curfew checks. SBCAT have carried out regular checks on multiple individuals who are wanted on warrant. During the past month there has been two high priority warrant executed. Both males subsequently appeared at court on these matters.

On the 28<sup>th</sup> November SBCAT officers took part in Border Rape Crisis Reclaim the Night March in Galashiels and worked alongside partner agencies providing advice and support for interested parties.

**DRUG ENFORCEMENT** – SBCAT officers have taken part in two drugs search warrants in the Scottish Borders.

One in Galashiels, unfortunately the search was negative, however disruption to the supply chain continues.

A second warrant was executed at an apparently disused mill on Dunsdale Road, Selkirk. Owing to the dilapidated state of the building, the clearing took longer than usual, with officers having to do locus protection for a number of days. Eventually following an in depth structural survey, limited amounts of officers were able to enter the building and dismantle the set up. There were approximately 1400 plants with a street value of over one million pounds. .
