Half an hour before the last meeting started, members were emailed a report which included a summary of the comments from community councils that pertained to the SBCCN before it folded. Fortunately, your Chair had discovered the report at the time of its arrival in the inbox and was able to review it. There is no disagreement with the contents. A number of suggestions were made going forward.

- Whatever the working group decide upon it should match the aspirations of the Scottish Government as expressed in those statutes that bear upon the subject, such as the Community Empowerment (Scotland) Act 2015, etc.
- The group needs a Terms of Reference
- Regarding the SBCCN replacement, a number of recommendations have been floated on the make up of areas. These include
  - Existing Area Partnership areas
  - School catchment areas
  - o Historical counties (Peeblesshire, Selkirkshire, etc.)
  - o ?
