#### 1.0 General

## **Tourist Signs**

There have been a number of emails that relate to the signage in the town and in particular that provided for tourists. There is some signage for tourists, but it is getting old, some is a bit old fashioned compared to modern standards and it doesn't all have the same theme. Apparently, there is a window in which some grant monies may be available.

How important is it? Your Chair considers it essential. Peebles is very much a tourist town and depends upon visitors for a lot of its income. The income to an extent helps maintain a vibrant High Street and supports our cafes and hotels. We can all see what is happening to many similar towns across Scotland and anything that helps avoid the same happening to Peebles has to be important. Further, some places such as Dornoch have great signage and this demonstrates just what can be achieved. I sent out the following email just to put a marker down:

I agree with Viv. There are plenty of tourist towns that have excellent signage that describes, history, architecture, etc. Generally, these all have a specific style. We should have the same. **Go Tweed Valley** is our local tourist organisation and **Civic Society** are likely to have the best handle on architecture and history. It would make sense to me that they worked closely together and perhaps PCC could work with them over grant applications, etc. A swift consideration gives me the following bullets

  - Border wars

- Sign style
  - Must have the 3 fishes

  - Cost of signage
  - Cost of placement
  - o Perhaps numbered for a tour of the town

# 5.0 Working party on non-financial support to community councils and the working party on the Community Councils Network.

At the meeting with SBC's CEO, your Chair had highlighted that the SBCCN project had not been heard from for circa 18 months and the Non-financial support projects was similar. Also, that SBC documentation showed that these were not separate projects, even though it appeared that they were being run in isilation. At the meeting on 23 September SBC formally apologised for the inertia and indicated that resource issues were to blame. In this respect, the meeting was informed that in this writer's views, if SBC were serious about

It is important to recognise that this meeting has been expanded to consider not only non-financial support issues, but also the SBCCN and indeed anything that the meeting members consider relevant.

On 09 September Michael Marshall and your Chair attended a Live Borders consultation meeting in the Burgh Hall. Clare Swan from the Drill Hall and PCCs former Chair, Les Turnbull were also there. Also present were representatives from "Schools Out", and Councillors Marshall Douglas and Robin Tatler, and some SBC support staff. The meeting was led by the new Live Borders CEO, Catriona McAllister. The members of the community made their points and formerly presented their documented submissions. It was a good meeting. However, what the outcome will be remains to be seen; anyway, we have probably done all that we were able to do for now. The new CEO made a favourable impression. SBC/LB issued a meeting note that we and Clare have responded to with suggested amendments. At the time of writing, we have not had a response, but then our submission was not too many days ago and SBC are not known for a fast reaction time on strategic issues. The meeting note, with our amendments in red is appended to this report.
