

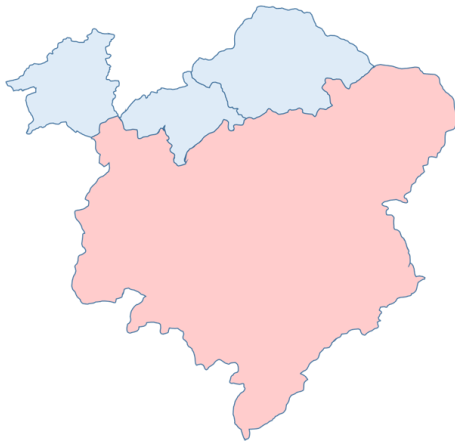

## Community Sergeant Update

During the course of February and March Police, along with partners in rural organisations, will continue to campaign to raise awareness among dog owners of the serious penalties related to incidents when a dog attacks or worries livestock animals. This is a particular problem when dogs, even those that are well trained, are off the lead or roaming without an owner. Many owners continue to be unaware of the impact their dogs are having on livestock but it is **their** responsibility to ensure that attacks and worrying don't happen.

The Dogs (Protection of Livestock) (Amendment) (Scotland) Act 2021 came into force in November 2021 to tackle the issue of out of control dogs attacking and worrying livestock. Under this law the consequences for dog owners that attack or worry livestock can be a fine of up to £40,000 or even a prison sentence of up to 12 months. The main message to prevent such attacks is to keep your dog under control and on a lead when near farm land and animals. To report such attacks by dogs the advice is to call 999 if the crime is ongoing and animals are being injured otherwise the matter can be reported via 101 or via an online Contact Us form on the Police Scotland website.

Improving road safety remains one of our local policing priorities in the Scottish Borders. With this in mind I wish to highlight a recent concerning figure which shows that on average 13% of those people killed on the roads in Scotland over the last five years were not wearing a seatbelt. As a driver it is your responsibility to wear your seatbelt and ensure all passengers under 14 years of age are wearing theirs. Wearing a seatbelt reduces fatal and non-fatal injuries by 60% in front seat passengers and 44 % in rear seat passengers so please wear a seatbelt for every journey and encourage your family and friends to do likewise.

Finally as Scotland rebuilds after the impact of the pandemic it is vital that we listen and respond to the views of the people in our communities. The #YourPolice survey is one of the ways that some meaningful views and opinions can be captured from the public. We know particularly that there may be areas in your community that you feel less safe and to address this there is a mapping tool in the survey to enable you to tell us more about them. This will allow us to work with partners to consider addressing such areas.

### Protecting most vulnerable



*In February 2022 Police in the Scottish Borders attended and were involved with around 169 mental health related calls, around 23 missing person enquiries and approximately 72 domestic related incidents.*

*Tweeddale East and West had 21 mental health related calls and 1 missing person enquiries. Due to GDPR and protection of victims/subjects involved, we are unable to share any more specific information in relation to these type of call within this report.*

*Police Scotland work in collaboration with key partners to assist the most vulnerable within the communities and to provide support.*



### Reducing Violence and Anti-Social Behaviour

#### Assaults

#### Anti-Social Behaviour

30/01/22 resident at Craigengar Gate, West Linton reported having issues with youths.

04/02/22 report of youths in School Brae causing problems at the Youth Club and kicking doors of a property. Officers attended and the youths ran off onto Tweed Green. No damage was caused.

12/02/22 report of youths shouting and swearing in School Brae, Peebles. Youths ran off on arrival of officers. No rubbish or damage found.

## OFFICIAL

16/02/22 report of youths causing problems at a property in Clelland Avenue, Peebles. Enquiries continuing.

24/02/22 report received of youths banging on windows at a property in Waverley Mills, Innerleithen.

25/02/22 report of male and female youths knocking a door in Waverley Road, Innerleithen. Officers traced the females who were apologetic and warned.

25/02/22 report that a 14 year old youth was intoxicated in School Brae, Peebles. Parents were contacted and took them home prior to police attendance.

26/02/22 report received regarding youths who were being abusive in School Brae, Peebles. Enquiries continuing.

26/02/22 report of youths banging on a door at a property in Rosetta Place, Peebles. Area was searched with a negative result.

27/02/22 report of youths throwing a bottle into a garden in Tweed Avenue, Peebles whilst the occupant was gardening.

### **Vandalism**

12/02/22 Scottish Fire and Rescue Service attended and extinguished a fire at the Vale of Leithen Football stand. Graffiti was also reported. After an appeal to the public three youths have been reported.

13/02/22 report of a hanging basket being destroyed at a property in School Brae, Peebles.



## **Reducing Acquisitive Crime**

### **Theft by Housebreaking**

Between 27/01/22 and 30/01/22 a shed was broken into at Edderston Road, Peebles and a bike stolen.

Between 07/02/22 and 08/02/22 three bikes were stolen. Two from a property at Dalatho Crescent and one from a garage at South Parks, Peebles.

Between 1400 and 2000 hours approximately on 8<sup>th</sup> February a Red Honda quad bike was stolen from a rural property in West Linton

Between 11/02/22 and 12/02/22 a shed was entered at Provost Blyth Square, Innerleithen and the contents of a freezer stolen.

## **Theft**

30/01/22 report received that a mobility scooter had been stolen whilst parked outside a caravan at Tweedside Caravan Site, Innerleithen. The vehicle was also damaged along with a fence belonging to the caravan park.

Between 31/01/22 and 01/02/22 an attempt was made to enter the coin machine at the toilets in Kingsmeadows Road, Peebles.

Between 02/02/22 and 07/02/22 a vehicle was broken into and a large quantity of power tools stolen while it was parked in Mill Car Park, Galashiels Road, Walkerburn.

09/02/22 a mobile phone and tablet were stolen from a property in Old Town, Peebles.

Between 10/02/22 and 11/02/22 a van was broken into whilst parked at High Cottages, Walkerburn and items stolen.

17/02/22 report that the coin box at toilets in Hall Street, Innerleithen has been ripped off the wall and the cash stolen.

24/02/22 report of 2 bikes stolen from separate properties in Tweedholm Avenue, Walkerburn.



## **Improving Road Safety**

Within the Selkirk Sheriff Court Jurisdiction there were 42 parking tickets issued in February.

31/01/22 driver reported for dangerous driving and a collision on the A701 at Lamancha.

12/02/22 driver has been reported to the Procurator Fiscal for driving offences and police assault after being involved in a road accident in Leithen Road, Innerleithen.

15/02/22 driver issued with a Fixed Penalty Notice for no MOT when stopped on A703.

26/02/22 driver issued with a fine for no MOT in Peebles.

## **Killed or Seriously Injured**

There were no accidents where persons were killed or seriously injured.

## Tackling Serious and Organised Crime



On the 2nd of February officers from across Police Scotland executed search warrants at multiple addresses across Hawick. During the enforcement £300 worth of Cannabis was recovered. Two males were arrested, one was reported in regards to the recovery of the drugs and another was reported for trading standards related offences.

On 4th of February officers attended an address in Hawick in relation to an outstanding arrest warrant. Circumstances developed at the address and officers subsequently search the address under search warrant, within the address was found £16,500 worth of Diamorphine. 5 persons were arrested and are to be reported for the offences identified.

On 8th of February officers executed a search warrant at an address in Kelso. Following a search of the address £3,500 worth of Cannabis was recovered. A male was arrested and reported for the offence.

On 17th of February officers from Police Scotland's Proactive Crime Team executed a drugs search warrant at an address in Kelso. Officers arrested a male within the property and following a search of the property found £420 worth of Diamorphine. The male has been reported for the offences.

## Campaigns

### Divisional Domestic Abuse campaign

Regular social media posts highlighting local (DAAS) and national helpline contact details and reporting mechanisms.

Ongoing engagement with main local employers to share campaign messages, information in relation to local support services and charities and prevention messages targeting perpetrators directly.

### Rural

Scottish Borders Partnership against Rural Crime (SBPARC) the partnership continues to meet regularly to address local priority rural crime throughout the year.

## CAT Update:



**DRUGS:** 4 warrants executed; cannabis recovered from an address in Kelso resulting in a male charged with being concerned in supply, two warrants at addresses in Hawick recovered significant amounts of heroin with a male and female being charged with being concerned in supply. A further warrant in Hawick resulted in personal amounts of heroin, cannabis and valium being recovered.

**ANTISOCIAL BEHAVIOUR:** ASB patrols carried out in hotspots, including School Brae in Peebles where 3 children were warned regarding behaviour, attention given to boy racers in Duns, and youth patrols in Burnfoot, Hawick.

**PARKING:** A further parking initiatives were carried out in Selkirk and Galashiels, again focusing on dangerous and inconsiderate parking such as double yellows, loading bays, taxi ranks etc, along with a letter drop to local businesses. Numerous tickets were issued. Further random checks will be carried out, and the initiative will be repeated in other towns in the future.

**QUAD BIKE THEFTS:** SBCAT are working closely with MCAT and Northumbria Police with regards quad bike thefts. Warrants were executed at three premises in Midlothian with stolen goods being recovered and one person charged. Two stashed quad bikes were recovered following a theft near Morebattle. Please can quad bike owners take precautions by storing in locked buildings where possible and not leaving keys in or near the quad. Report any suspicious vehicles to police immediately using 101, and where possible provide details of the vehicles.
