## Community Sergeant Update

### PS Stephen Granger

I am aware of the recent positive announcements from many towns in the Borders in relation to their annual events and local festivals which will be taking place in the spring and summer of 2022. I understand the importance of these events to towns and the disappointment people will have felt previously when these events have been cancelled due to the pandemic. This is great news for all our communities and planning is well under way by police to ensure events pass safely.

I would like to take the opportunity, given its importance, to highlight an extremely important issue which many of you will have read in local media. The Scottish Borders has unfortunately been one of the areas of Scotland targeted by scammers impersonating police officers which has seen more than £300,000 being defrauded from victims across Scotland. Between October and January over 30 reports have been received from members of the public nationally who have either been visited or contacted by individuals claiming to be Police Scotland officers.

On each occasion the victim was contacted by telephone from someone claiming to be from the bank fraud department and advised that their bank account had been compromised. They were then requested to transfer money remotely or attend at the bank and remove cash which would later be collected by a police officer. Investigations are ongoing into these incidents but with a view to preventing further crimes of this nature taking place, always be suspicious of unexpected contacted by police and follow this advice:

- If you receive a call or a visit ask for the officer's details and which department they work for. If it is a visit ask to see identification. New police identification cards were rolled out in October 2021 which feature an up to date picture of the officer and have other security features that are extremely difficult to replicate. All police officers should be able to produce this on every occasion when requested.
- If contact is by telephone hang up **and if possible use a different phone** to contact Police Scotland via 101 to request verification of the person's identity.
- If you receive an email claiming to be from Police Scotland with a link to an external site to make a payment this may also be fraudulent. Any link of this type must be verified to confirm it is genuine and this can be done via contacting 101 to investigate **before parting with any money.**

Finally I am aware that there has been recent complaints throughout many towns in the Borders regarding anti social driving and particularly the use of vehicles with excessively loud exhausts. Be assured that officers will take proportionate action when they see/hear such vehicles during the course of their duties.

I would encourage members of the public affected by this type of behaviour to report the matter directly to police at the time via 101 or alternatively via email. When possible this should include details of the driver if known and/or the make model or registration number of the vehicle concerned. If officers cannot be dispatched to the incident at time of report this information may

allow for some follow up by officers with the registered keeper or driver of the vehicle at a later time either via a physical visit or a letter to provide a warning or offer advice.

### **Protecting most vulnerable**

*In January 2022 Police in the Scottish Borders attended and were involved with around 137 mental health related calls, around 11 missing person enquiries and approximately 72 domestic related incidents.*

*Tweeddale East & West had 19 mental health related calls and 2 missing person enquiries. Due to GDPR and protection of victims/subjects involved, we are unable to share any more specific information in relation to these type of call within this report.*

*Police Scotland work in collaboration with key partners to assist the most vulnerable within the communities and to provide support.*



### **Reducing violence and ASB**

#### **Assaults**

The assaults reported come under Domestic Abuse and due to GDPR we are unable to share details.

#### **Anti-Social Behaviour**

01/01/22 report of youths throwing items at St. Ronan's Primary School. Four youths ran off on police attendance and there was no damage found.

03/01/22 report of eggs having been thrown at a property in Hall Street, Innerleithen.

07/01/22 male refusing to leave the Cross Keys, Northgate, Peebles was issued with a Recorded Police Warning.

09/01/22 male issued with a Recorded Police Warning for urinating on High Street, Peebles.

15/01/22 report received that youths were within the grounds of Halyrude School, Peebles possibly causing damage. Officers attended and there was no trace of the youths or any damage found.

16/01/22 two visitors to a hotel in Peebles were issued with Recorded Police Warnings due to their conduct within the hotel.

21/01/22 report of problems with youths at the Masonic Lodge, Chapel Street, Innerleithen. Officers attended, no trace of any youths and no visible damage.

23/01/22 report of eggs being thrown at a property in Dyer Close, Innerleithen. No damage was caused, officers are making further enquiries.

### **Vandalism**

02/01/22 property in Morningside, Innerleithen was damaged.

03/01/22 report that damage had been caused to the garden/poly tunnels and Nursery at St. Ronan's Primary School, Innerleithen. After enquiry three youths were identified as being responsible and will be reported to the Children's Reporter/Youth Justice Services.

03/01/22 report of cars being damaged in Old Church Road and Cross Road, Peebles.

05/01/22 report of youths within Halyrude Primary School. On police arrival the Fire Service were in attendance and no youths were present, it appeared that some paper had been burnt.

07/01/22 report of graffiti on the play park and a bench within Victoria Park, Peebles.

26/01/22 youths have damaged a door of a property in Hall Street.

26/01/22 report of a gate being damaged at the Vale of Leithen Football ground, Innerleithen.

## Reducing acquisitive crime

### **Theft Housebreaking**

27/01/22 report of a garage being broken into on Peebles Road, Innerleithen and items stolen.

### **Theft**

05/01/22 report of a lorry battery being stolen from a yard in North Street, Peebles.

Between 7<sup>th</sup> and 9<sup>th</sup> January 5 vehicles had tyres damaged at a property in West Linton.

Between 1530 and 1600 hours on 10<sup>th</sup> January 2022 an electric bike was stolen from the rear of a vehicle in East Station Car Park, Peebles.

14/01/22 report received that a wildlife camera had been stolen from land of rural property in Innerleithen.

Between 1<sup>st</sup> November 2021 and 6<sup>th</sup> January 2022 a quantity of heating oil was stolen from a property near Cardrona.

20/01/22 report of 3 female youths attempting to steal items from a shop in Eastgate, Peebles. Further enquiries being made.



### Improving road safety

Within the Selkirk Sheriff Court Jurisdiction there were 15 parking tickets issued in January.

07/01/22 a driver has been reported for failing to report a road accident which occurred in Dean Park, Peebles.

19/01/22 a driver has been reported for various road traffic offences after being stopped in Innerleithen.

26/01/22 a driver was issued with a Conditional Offer for driving on the A72 near Peebles without an MOT Certificate.

### Killed or Seriously Injured

There were no accidents where persons were killed or seriously injured.



### Tackling serious and organised crime

On 11<sup>th</sup> of January 2022 officers from across the Scottish Borders executed search warrants at three addresses in Hawick. Systematic searches of the addresses, saw £1000 cash along with controlled drugs with an approximate street value of £9000 recovered. A female has been reported for being concerned in the supply of controlled drugs.

On 27<sup>th</sup> of January 2022 officers from across the Scottish Borders executed a search warrant at an address in Hawick. A systematic search of the address, saw £2590 cash along with controlled drugs with a street value in excess of £30,000 recovered. Two males were arrested and investigations are continuing into the supply of these controlled drugs.

### Rural

- Scottish Borders Partnership against Rural Crime (SBPARC) the partnership continues to meet regularly to address local priority rural crime throughout the year.



- We continued to distribute free Selecta DNA forensic marking kits & signs and crime prevention advice to farmers and rural business. ### CAT Update:

**DRUGS:** Following receipt of intelligence, three premises in Hawick were searched by SBCAT under Misuse of Drugs Act warrants. Class A drugs with a potential street value of over £11,000 were seized, along with over £1000 in cash. Two persons have been reported to the Procurator Fiscal.



A further house was searched in Hawick, again under an MDA Warrant, which resulted in the recovery of class B drugs with a potential street value of £20,000 to £30,000. Two males were arrested and interviewed, with enquiries ongoing prior to supply charges being brought. A report will be sent to the PF in due course.

**ANTISOCIAL BEHAVIOUR:** Following previous issues of vandalism in Innerleithen, a swift enquiry resulted in three youths being identified and charged with a number of vandalisms in the area.

**PARKING:** Attention given to Kelso, with tickets issued focussing on the dangerous and inconsiderate parking, i.e. double and single yellows, loading bays, taxi ranks etc. A letter drop to businesses in the town centre was completed, alongside social media messaging supported by posts by Kelso Community Council and Visit Kelso. This appeared to have a good affect, with positive responses to social media commenting on the availability of parking spaces following the work. Random checks will be carried out going forward.

**QUADS:** The quads have been put to good use, with two days of action in Moneynut Forrest due to further reports of off-road bikers in the area. Seven persons have been charged with road traffic offences in the area.

The quads were also utilised for a day of action for Operation Galileo, which is the national operation targeting hare coursing. While reports of hare coursing in the borders have decreased of late, this is due in the main two days of action like this. Further dates are planned in the coming months.
